Acceptable Proof and Lawful Presence Documents

MPERS will need a copy of one of the following proof documents to verify your identification. The list of acceptable documents is the same as those used by the Department of Revenue for a driver's license. A photocopy of one of the following documents must be submitted with this election form:

- US Birth Certificate
- US Passport (valid or expired)
- Certificate of Citizenship
- Certificate of Naturalization
- Certificate of Birth Abroad
- Valid Missouri Driver's License

If there is any difference between the information provided on this form and the law or policies that govern MPERS, the law and policies will prevail.
