Elections were held for Chair and Vice Chair. Mr. Bill Seibert will serve as Chair and Mr. Todd Tyler will serve as Vice Chair. Mr. Seibert had previously served as the Vice Chair during the past two years.

## **Investment Performance**

Presenters: Larry Krummen, Chief Investment Officer (MPERS) & Kevin Leonard (NEPC)

As of December 31, 2018, MPERS' returns ranked in the top 3% of the peer universe across all measurement periods out to 10 years. The low-risk profile for the last 10 years also ranked in the top 3% of the universe. The combination of strong returns and low-risk profile over the last 10 years resulted in MPERS obtaining a risk adjusted return that rated in the top 1% of the public fund peer universe which comprises several hundred funds.

## **Investment Committee Report**

Presenter: Mike Pace (Investment Committee Chair)

Mr. Leonard (NEPC) presented the 2019 Asset Class Assumptions. This is an annual overview of what the investment consultant views as economic and investment themes, actions and opportunities for the coming year.

Mr. Krummen presented on several topics required by policy, including the investment manager due diligence report, the proxy voting policy and a review of the internal fixed income portfolio.

The Investment Committee voted to recommend to the full board to rescind some of the governance policy changes adopted at the November 2018 meeting. The change would no longer allow the addition of leverage to the MPERS' portfolio.

Trustee McKenna presented for the full Board material similar to that presented in the morning session for the Investment Committee, on a variety of topics related to alternative investments and concerns he sees in the investments industry.
