Election of Board Chair and Vice Chair and Appreciation to Existing

Introductions of New Employees

Mr. Simon introduced two new MPERS' employees to the Board. Bobby Hagedorn joined our team in November, 2013 as a Senior Investment Officer. Jamie Mullen came on board in January, 2014 as a Benefit Specialist. Mr. Mullen will take Mariel Hale's position when she retires.

Legislative Update

Presenter: Scott Simon, MPERS' Executive Director

Mr. Simon discussed several bills that could potentially affect the System including HB 1682, HB 1800 and HB 1882. Bill filing for the Senate ended on February 27th but the House can continue to file bills through mid-March. Audit Committee — Gabriel, Roeder, Smith & Company (GRS) Contract Extension

Presenter: Mr. Ken Suelthause, Audit Committee Chair

The Audit Committee recommended extending the GRS contract, which is due to expire on June 30, 2014, for an additional year, since we are currently in the middle of implementing new reporting for GASB Statements 67 and 68, which demands considerable familiarity with our System. Mr. Simon noted that an additional extension is likely to be recommended next year as the new requirements will not be completed by end of FY 2015. The Board approved a one-year extension to the current contract which will now expire June 30, 2015.

Governance Committee

Presenter: Kenneth Suelthaus, Board Governance Committee Chair

A new appraisal form and process for the Executive Director was proposed by the Governance Committee and approved by the Board. The new form and process will streamline the appraisal process and will be conducted in September rather than November of each year.

Budget Committee — Mid-Year Budget Review

The System is on track as far the FY 2014 budget is concerned; however, due to the departure of the System's general counsel, increased external legal costs are expected.

2013 Calendar Year Investment Performance Report

Presenter: Kevin Leonard, NEPC

The System performed well in 2013 finishing the year with a 14.96% return (10th percentile compared to our peers). The benchmark returned 12.55%. Achieving top quartile risk-adjusted returns is quite impressive for a fund that has a much smaller global equity allocation than most public pension plans.

Other Business

The 2014 cost-of-living (COLA) rate is 1.172%.
