MPERS Board Election

The election for the active MSHP and active MoDOT employee representatives on the MPERS Board of Trustees closed on Thursday, May 31, 2018, at 4:00 p.m. Both Sgt. Matthew Broniec and Mr. Todd Tyler were re-elected by the active members of MoDOT and MSHP. The elected retiree representatives were uncontested and both Ms. Sue Cox and Mr. Bill Seibert remain representatives for the retirees. The board certified the election results by unanimous vote at their June 21st meeting.

Video Counseling

MPERS is pleased to announce that we now offer video counseling sessions. This new method of communication is made available through our partnership with MoDOT and is available to employees of MoDOT and the Highway Patrol. While such capabilities would reasonably be used more often by our members who are located the greatest distances from Jefferson City, any member is invited to use this new communication tool.

We have a section on our website (www.mpers.org) dedicated to video counseling information. It can be found under "Members" and then "Seminars/Counseling."

As HR representatives, we expect that you field questions on retirement related matters and we can anticipate requests from you or your employees to utilize this new communication tool to speak with our benefit counselors. While there will be some work on your part to offer this new tool to your employees (assuming you choose to do so) there are some potential savings in both employee time and money by eliminating a trip to Jefferson City.

Our use of video counseling is not intended to reduce the number of pre-retirement seminars or special counseling sessions at your office, district or troop. Rather, it is simply one more way we can reach out to your employees/our members to answer questions they may have. We believe the face-to-face video experience may alleviate some trepidation when making retirement decisions.

Both employees and employers can use this communication tool. There are some basic requirements listed below that are needed in order to use this new tool:

- A computer, tablet, or smartphone with high-speed internet connection, speakers, microphone, and a video camera (most newer laptops have video cameras)
- Google Chrome or Firefox web browser
- Link to online video counseling: <https://join.modot.org/>

If you have a desktop computer and need a video camera, we found a "**Logitech C930e webcam**" on Amazon to be inexpensive (less than \$90) and we will be using it on our end for the video counseling sessions.

We hope you and your employees take advantage of this new method of communication.
