# <u>Clarification from Meeting – 2011 Tier Beneficiaries</u>

We did have a topic come up during our benefits meeting that needed some follow-up and clarification.

### Question:

If a member of the 2011 Tier passed away and listed someone other than a spouse as the beneficiary of their employee contributions (and there are no survivor benefits due), who would receive the balance of the employee contributions – the current spouse or the beneficiary the member had listed?

#### Answer:

The recipient of the employee contribution balance in this scenario would be whomever the member listed as the beneficiary, regardless of current marital status.

Given the importance of beneficiary designations, please continue to remind your employees to keep their beneficiary information up to date. As they come in to fill out other survivor paperwork when a life changing event occurs, please have them check or update their beneficiary(ies) listed for their employee contributions as well. Beneficiary information is listed on their annual benefit statement and can also be viewed in their *myMPERS* Secure Member Access. If you have any other questions or concerns about this topic, please feel free to contact us.
