Divorce After Retirement Legislation

Legislation was recently passed that will allow retirees who elected a joint & survivor option at retirement and later divorce to have the benefit revert to a single life income annuity. In order for the change to be effective, MPERS must receive a completed application as well as approve a divorce decree or amended divorce decree dated on or after January 1, 2021, that provides sole ownership by the member of all rights in the annuity and must further state that the former spouse shall not be entitled to any survivor benefits (per sections 104.090.7 and 104.1027, RSMo.). Please contact our benefit specialists if you have questions regarding this change. Once our materials are updated and implementation process is in place, we will provide you with more information.
