## In Memoriam



We would like to recognize Jane\*, our eldest payee, who passed away recently at the age of 106. Jane was the survivor beneficiary of one of our members who passed away in 1981; a short seven years after his retirement. Because of the survivor benefit that MPERS offers, Jane was able to continue receiving a monthly benefit for the next 39 years until her passing in 2020.

Jane's story is a reminder of the value of the MPERS pension benefit. Jane didn't need to worry about losing her husband's pension benefit once he passed away. MPERS is a defined benefit pension plan and the benefit is payable for the lifetime of the retiree, and if a survivor payment option is selected at retirement, it is payable for the lifetime of the survivor. Even when the survivor lives to be 106.

The Mid-Career Checkup is a new webinar offering for those who wish to plan for retirement sooner, rather than later, in their career.

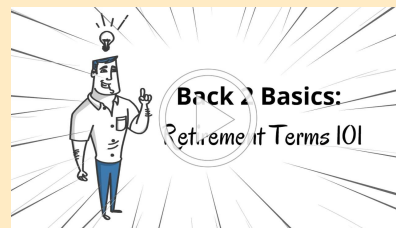
